6. ACCIDENTAL RELEASE MEASURES:

Personal precautions, protective equipment and emergency procedures

Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Keep unauthorized personnel away.

Methods and material for containment and cleaning up

Eliminate all ignition sources if safe to do so. Use only non-sparking tools. Take precautionary measures against static discharges. Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.

Notification Procedures

Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.

Environmental precautions

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.


