**6. ACCIDENTAL RELEASE MEASURES:**

<b>Personal precautions, protective equipment and emergency procedures</b>	:	Advice for non-emergency personnel: Avoid inhalation of dusts. Avoid substance contact. Ensure adequate ventilation. Evacuate the danger area, observe emergency procedures, consult an expert.

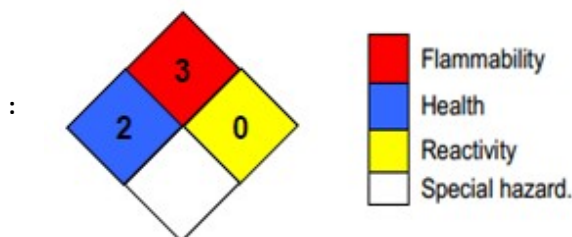
