6. ACCIDENTAL RELEASE MEASURES:

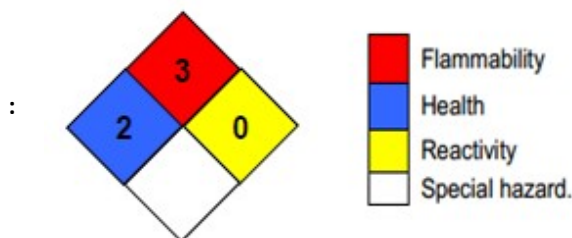
