Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. Prevent buildup of vapors or gases to explosive concentrations. Vapor from the solvent may accumulate in container headspace resulting in flammability hazard. Heat may cause the containers to explode.

6. ACCIDENTAL RELEASE MEASURES:

Eliminate all ignition sources if safe to do so. Use only non-sparking tools. Take precautionary measures against static discharges. Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger

spill for later recovery and disposal.


