Special protective equipment and precautions for firefighters

- Special firefighting procedures : Fight fire from a protected location. Move containers from fire area if you can do so without risk.
- Special protective equipment for fire-fighters : Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA.

6. ACCIDENTAL RELEASE MEASURES:

Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.
- Notification Procedures : Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.
- Environmental precautions : Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.

- Precautions for safe handling : Do not handle until all safety precautions have been read and understood. DO NOT handle, store or open near an open flame, sources of heat or sources of ignition. 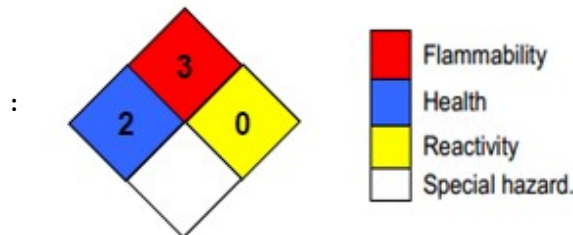
