Specific hazards arising from the chemical

Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. Prevent buildup of vapors or gases to explosive concentrations. Vapor from the solvent may accumulate in container headspace resulting in flammability hazard. Heat may cause the containers to explode.

Special protective equipment and precautions for firefighters

Special firefighting procedures

Use water spray to keep fire-exposed containers cool. Water may be ineffective in fighting the fire. Fight fire from a protected location. Move containers from fire area if you can do so without risk.

Special protective equipment for fire-fighters

Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA.

6. ACCIDENTAL RELEASE MEASURES:

Personal precautions, protective equipment and emergency procedures ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Avoid breathing mists or vapors. Keep upwind. Ventilate closed spaces before entering them. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Keep unauthorized personnel away.

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.

Precautions for safe handling


