Special firefighting procedures : Carbon oxides Sulphur oxides Hydrogen chloride gas Combustible. Development of hazardous combustion gases or vapours possible in the event of fire.

Special protective equipment for fire-fighters : Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA.

6. ACCIDENTAL RELEASE MEASURES:

Personal precautions, protective equipment and emergency procedures : Advice for non-emergency personnel: Avoid inhalation of dusts. Avoid substance contact. Ensure adequate ventilation. Evacuate the danger area, observe emergency procedures, consult an expert.

Methods and material for containment and cleaning up : Eliminate all ignition sources if safe to do so. Use only non-sparking tools. Take precautionary measures against static discharges. Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.

Notification Procedures : Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.

7. HANDLING AND STORAGE:

Precautions for safe handling : Do not handle until all safety precautions have been read and understood. Do not handle, store or open near an open flame, sources of heat or sources of ignition. Protect material from direct sunlight. Take precautionary measures against static discharges. Ground/bond container and receiving equipment. 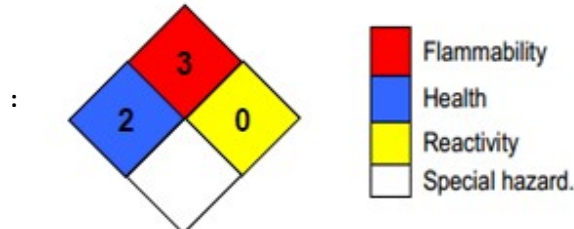
