Special protective equipment and precautions for firefighters

Special firefighting procedures : Fight fire from a protected location. Move containers from fire area if you can do so without risk.

Special protective equipment for fire-fighters : Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA.

6. ACCIDENTAL RELEASE MEASURES:

Personal precautions, protective equipment and emergency procedures : ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Avoid breathing mists or vapors. Keep upwind. Ventilate closed spaces before entering them. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Keep unauthorized personnel away.

Methods and material for containment and cleaning up : Eliminate all ignition sources if safe to do so. Use only non-sparking tools. Take precautionary measures against static discharges. Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.

Notification Procedures : Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.

Environmental precautions : Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.

7. HANDLING AND STORAGE:

Precautions for safe handling : Do not handle until all safety precautions have been read and understood. DO NOT handle, store or open near an open flame, sources of heat or sources of ignition. Protect material from direct sunlight. Take precautionary measures against static discharges. Ground/bond container and receiving equipment. 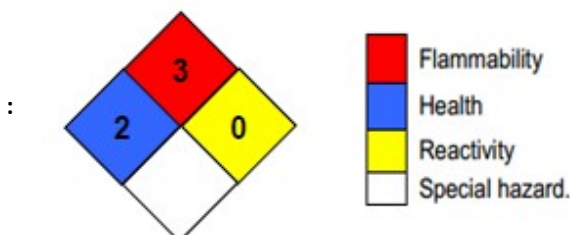
