Special protective equipment and precautions for firefighters

Special firefighting procedures	:	Fight fire from a protected location. Move containers from fire area if you can do so without risk.

Dike far ahead of larger spill for later recovery and disposal.
Notification Procedures	:	Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.

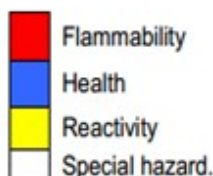
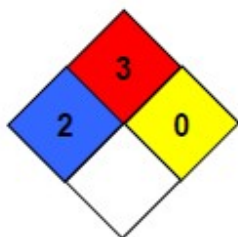
