**4. FIRST AID MEASURES:**

**Special protective equipment and precautions for firefighters**

- Special firefighting procedures** : Use water spray to keep fire-exposed containers cool. Water may be ineffective in fighting the fire. Fight fire from a protected location. Move containers from fire area if you can do so without risk.
- Special protective equipment for fire-fighters** : Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA.

**6. ACCIDENTAL RELEASE MEASURES:**

- Personal precautions, protective equipment and emergency procedures** : ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Avoid breathing mists or vapors. Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.
- Notification Procedures** : Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.
- Environmental precautions** : Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.

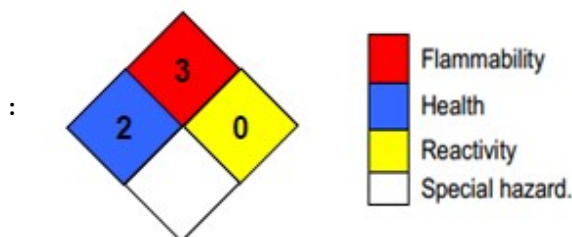
