**4. FIRST AID MEASURES:**

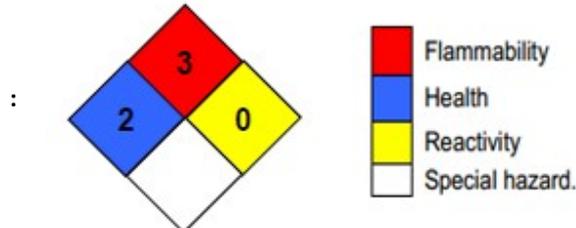
