**6. ACCIDENTAL RELEASE MEASURES:**

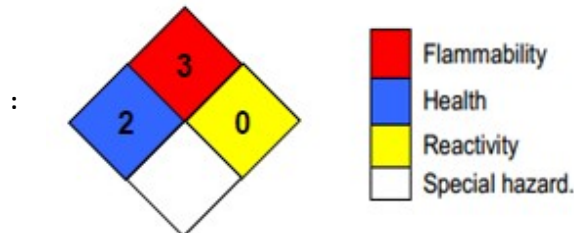
