Suitable extinguishing media : Water Foam Carbon dioxide (CO₂) Dry powder.

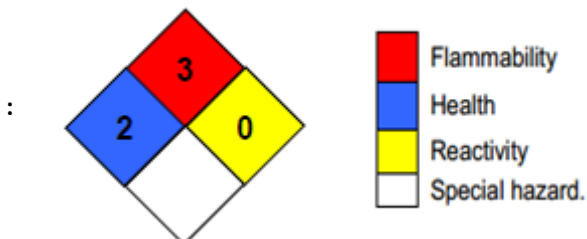
