6. ACCIDENTAL RELEASE MEASURES:

Personal precautions, protective equipment and emergency procedures	:	ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Avoid breathing mists or vapors. 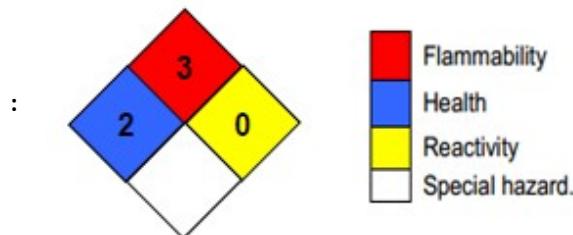
