<b>Suitable extinguishing media</b>	:	Water spray, foam, dry powder or carbon dioxide.
<b>Unsuitable extinguishing media</b>	:	Avoid water in straight hose stream; will scatter and spread fire.
<b>Specific hazards arising from the chemical</b>	:	Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. Prevent buildup of vapors or gases to explosive concentrations. Vapor from the solvent may accumulate in container headspace resulting in flammability hazard.
