<b>protective equipment and emergency procedures</b>	Avoid breathing mists or vapors. Keep upwind. Ventilate closed spaces before entering them. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Keep unauthorized personnel away.
<b>Methods and material for containment and cleaning up</b>	Eliminate all ignition sources if safe to do so. Use only non-sparking tools. Take precautionary measures against static discharges. Stop leak if possible without any risk. : Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.

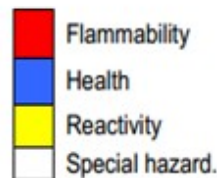
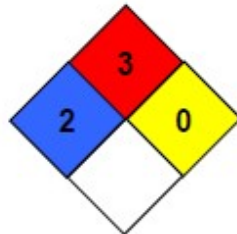
