**Precautionary statement**

**4. FIRST AID MEASURES:**

**5. FIRE FIGHTING MEASURES:**

General information : Flammable liquid and vapor.

**Suitable (and unsuitable) extinguishing media**

Suitable extinguishing media : Foam, dry powder or carbon dioxide.

Specific hazards arising from the chemical : Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. Heat may cause the containers to explode.

**Special protective equipment and precautions for firefighters**

Dike far ahead of larger spill for later recovery and disposal.

Notification Procedures : Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.

Environmental precautions : Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.

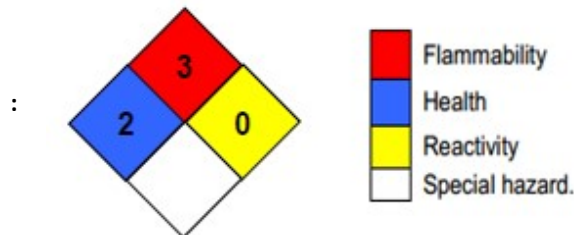
