Special protective equipment and precautions for firefighters

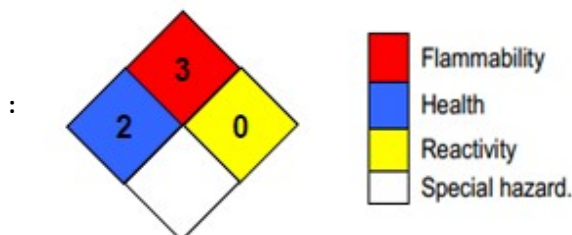
