Special protective equipment and precautions for firefighters

- Special firefighting procedures** : Fight fire from a protected location. Move containers from fire area if you can do so without risk.

6. ACCIDENTAL RELEASE MEASURES:

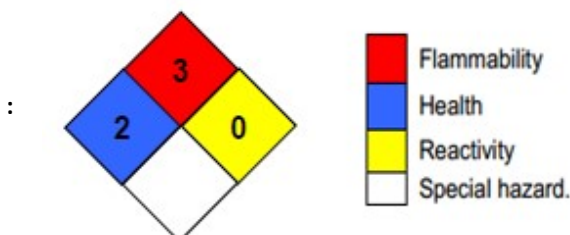
