5. FIRE FIGHTING MEASURES:

Suitable (and unsuitable) extinguishing media

Suitable extinguishing media : Dry powder, Foam, Water spray, Carbon dioxide (CO₂).

Unsuitable extinguishing media : For this substance/mixture no limitations of extinguishing agents are given.

Specific hazards arising from the chemical : Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. Prevent buildup of vapors or gases to explosive concentrations. Vapor from the solvent may accumulate in container headspace resulting in flammability hazard. Personal precautions, protective equipment and emergency procedures : Advice for non-emergency personnel: Avoid inhalation of dusts. Avoid substance contact. Ensure adequate ventilation. Evacuate the danger area, observe emergency procedures, consult an expert.

Methods and material for containment and cleaning up : Eliminate all ignition sources if safe to do so. Use only non-sparking tools. Take precautionary measures against static discharges. Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.

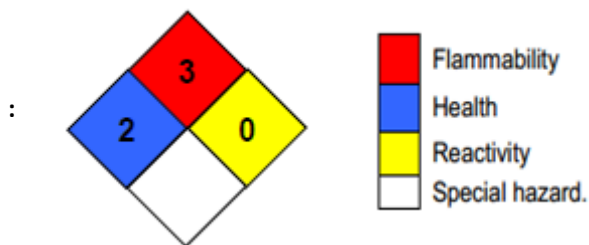
