Suitable (and unsuitable) extinguishing media

Suitable extinguishing media : Water Foam Carbon dioxide (CO₂) Dry powder.

Specific hazards arising from the chemical : Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. 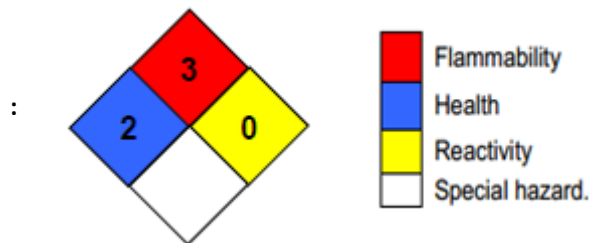
