**Specific hazards arising from the chemical** : Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. 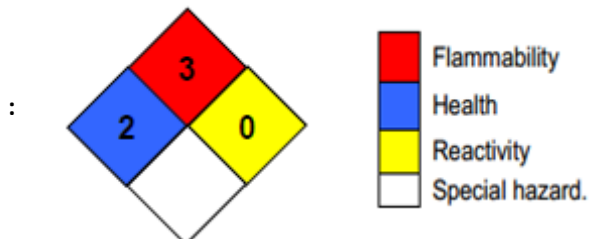
