Suitable (and unsuitable) extinguishing media

Suitable extinguishing media : Water Foam Carbon dioxide (CO₂) Dry powder.

Unsuitable extinguishing media : For this substance/mixture no limitations of extinguishing agents are given.

Specific hazards arising from the chemical : Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.

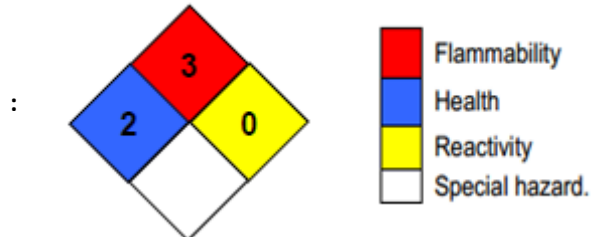
