**Suitable extinguishing media** : Water Foam Carbon dioxide (CO<sub>2</sub>) Dry powder.

**Specific hazards arising from the chemical** : Vapors may cause a flash fire or ignite explosively. Vapors may travel considerable distance to a source of ignition and flash back. 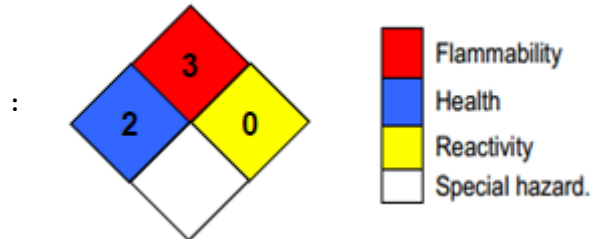
