Suitable extinguishing media : Water Foam Carbon dioxide (CO₂) Dry powder.

Dike far ahead of larger spill for later recovery and disposal.

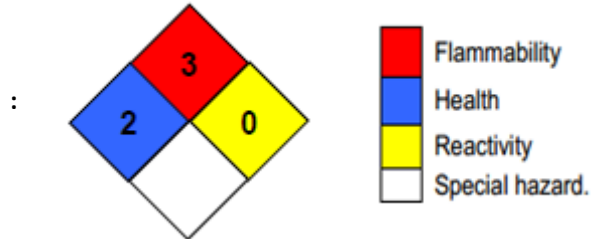
