<b>Prevention</b>	: Obtain special instructions before use. Do not breathe dust/ fume/ gas/ mist/ vapors/ spray. Do not handle until all safety precautions have been read and understood. Heat may cause the containers to explode.

**Special protective equipment and precautions for firefighters**
