**Suitable extinguishing media** : Water Foam Carbon dioxide (CO<sub>2</sub>) Dry powder.

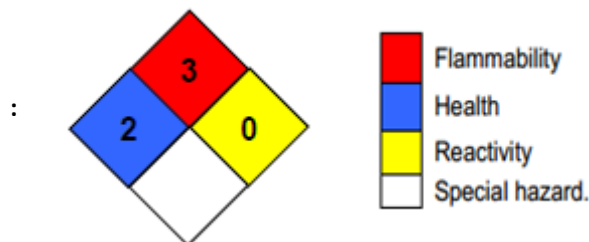
