<b>Special firefighting procedures</b>	:	Use water spray to keep fire-exposed containers cool. Water may be ineffective in fighting the fire. Fight fire from a protected location. Move containers from fire area if you can do so without risk.

**6. ACCIDENTAL RELEASE MEASURES:**

Stop leak if possible without any risk. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.
<b>Notification Procedures</b>	:	Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.
